



Foremost Auto Rideshare Coverage Information



BACKGROUND

- Rideshare drivers are unlike taxi or limousine drivers, which are traditional livery. Rideshare drivers are non-commercial drivers using their personal vehicle to transport passengers for compensation.
- Ridesharing is gaining in popularity, with an estimated number of over 500,000 drivers in 2015¹.

WHAT IS COVERED UNDER RIDESHARE

- The Rideshare endorsement applies only to the auto for which the endorsement is listed on the policy Declarations Page.
- This is an an extension of those coverages displayed on policy Declarations Page during the time period commencing :
 - When the insured is available to receive requests for transportation through a digital network or similar connection used by a Transportation Network Company, and
 - Ending when the insured and the Rideshare covered auto are engaged in a Prearranged Ride.

Prearranged Ride: Means a period of time that begins when a driver accepts a requested ride through a digital network or similar connection and continues while the driver transports the rider in a personal auto. It ends when the rider departs from the personal auto (periods 2 and 3 in the illustration).

Transportation Network Company:

means a corporation, partnership, sole proprietorship, or other entity that uses a digital network or similar connection to connect riders to drivers for the purpose of providing transportation.
