




WHAT IS TRAFFIC SCHOOL?

Traffic school is a program where a defendant that received a moving violation receives instructions on traffic safety that can enhance their driving knowledge and skill level.

By attending traffic school it will mask the conviction on their driving record.





Who is eligible to attend Traffic School?

• The defendant will have the option to attend traffic Note: You can still register a customer even school when they receive their traffic citation in mail to explain the process about court fees to be paid first before finishing traffic school.

- They have to pay the court's administrative fee to attend traffic school. (If not their certification will be rejected)
- Once all court fees are paid they have 90 days to complete Traffic School.



If the customer's due date has passed, then the court closed their case and reported the violation to the DMV as a point. They will need to contact the court and request to reopen their case if they still wish to take traffic school. The court will not accept or process their certificate with the DMV unless the case is approved for traffic school.

YOU <u>CANNOT</u> GO TO TRAFFIC SCHOOL FOR:

- Non-moving offenses (like parking offenses)
- Misdemeanors
- Alcohol- or drug-related offenses
- Equipment offenses Example: Illegal tint, defective headlights ex.
- Offenses in a commercial vehicle Speeding over
 25 mph the limit
- If attended traffic school within the previous 18 months.



Or if your violation carries more than 1 point- such as:

Driving with a suspended license, Failing to stop at an accident scene, Speeding in excess of 100 miles per hour, Reckless driving, Engaging in speed contests

The security question answers are going to be the birth year as well for faster registering.

Pursuant to Vehicle Code section 1808.7, the following situations are not eligible for masking a traffic safety violation on a California driver record:

- The driver has already attended a traffic violator course within 18 months of the conviction.
- The driver holds a commercial license as defined in Vehicle Code section 15210.



Course content is limited to traffic violator curricula approved by the Department of Motor Vehicles. Students in the classroom include traffic offenders repeat traffic offenders, adults, and teenagers, and those who have and those who have not been referred by a court. Instructor training, business

regulatory standards, and Vehicle Code requirements of traffic violator schools are not equal to the training, standards, and Vehicle Code requirements of licensed driving schools (California Vehicle Code Section 11200(b)(1)).


