**Void Process** 

Application submissions may be voided by contacting Customer Service and uploading a LIABILITY RELEASE FORM within 24 hours of transmission. Forms are available at reliant.connectinsurance.com. If more than 24 hours has passed since application upload, a signed cancellation request must be submitted to Reliant General. The policy will be cancelled pro-rata on the date of the request and all fees will be fully earned. Policies for which a cancellation request is received after a 24 hour period of transmission will not be voided – no exceptions.
