Named Insured	Anyone can be listed as the named insured, it does NOT need to be the registered owner,
	you may exclude the registered owner
Accept out of state license / reg	YES (Do not require insured to obtain CA lic or reg)
Acceptable Special Vehicles	Salvaged/Gray Market- liability only (unless CA GDD), Van conversion - ACV limit only
Annual Mileage	Actual Mileage
	Yes, surcharge applies. For full list of acceptable vehicles refer to the underwritng guide.
Business or Artisan	Sample acceptable useage is: sales or service reps, home sales, real estate or insurance
	agent professionals visiting multiple locations; No more than 2 job sites per day, must be
	registered to named insured
Clue Report	YES, run prior to binding along with MVR (order reports)
Comp Cov w/ Existing Damage	YES, listed on inspection form
Coverages - Comp / Coll	250, 500, 1000, 2000, available for vehicles up to 20 years old
Comp w/out collission	Yes
Coverages - Leinholder Deductible	\$1.20 per month; 100/250 deductibles
Coverages - Liability	15/30/5 up to 100/300/100
Coverages - Special Equipment	\$1.20 per \$100 value (Comp/Coll must be purchased)\$3,000 max; Stereo equipment limited
Coverages - Special Equipment	to \$1,000
Coverages - UMBI / UMPD	15/30 to 30/60; 3,500
Discounts	Good Driver (20%), Multi-Car, Defensive Driving Course (10%)

International License	YES (Do not require US license)

Lifted/Lowered	Not acceptable
Money Needed for endorsement	NO, we do offer a suggested payment
Non-Owner	YES
Paperless / File Maintenance	YES - retained signed apps in office, e-Signature also available
Insured Payments	Via Phone, Internet, Mobile App, text alert or Mail, Credit Card, E-Check or Western Union.
Policy Terms	6 & 12 month terms, optional down payments and paid infull
Proof of Marriage	Not required
Reinstatement Period	60 Days, additional 12 months to EZStart
SR 22	YES, no fee charged
Violations	1 violation charge per day (ex. 1 major and 1 minor on same day, only charge for major)
MVR Violation	24 months for 2 pt vios, all other 36 month

Mexico Limited Coverage	Occasional travel into Mexico up to 25 miles. Applies to all coverages. Infrequent trips into Mexico where all insured persons collectively have spent ten or fewer days in Mexico and made five or fewer trips into Mexico during a thirty-day period.
Replacement/Additional Vehicle	14 days
Permissible Operator	Coverage drops to state minimum limits for unlisted drivers
	YES, Non-reimbursement: Two tiers Up to \$75/incident or up to \$100/incident. Serviced
Roadside	through Agrero (formely Road America), negotiated pricing in their network.

Towing & Labor	YES, available on liability only or physical damage policies, up to \$50
Rental Reimbursement	\$25 a day, \$750 max
Car Loan Protection	Increases Physical Damage on total loss vehicles to ACV or loan balance
Deductibles	Deductible does not apply for window glass repair
Bill Alerts	Available via text or Email, notifies insured in advance of installment due, English & Spanish
