Acceptable Vehicles	Standard, Cruiser, Touring, Sport Touring, Sport Bike, Dual Purpose, Scooter/Moped, Trike, Reverse Trike Autocycle, Electric Bikes, Limited Production Motorcycle (pre-approved manufacturer only), Vintage
Annual Mileage	Actual. 5001 if not provided
Additional Coverages	Optional Equipment (first \$3000 are covered), Replacement Cost, Physical Damage PLUS, Rental Reimbursement (bike or car), Roadside Assistance, Excursion Diversion, Accidental Death & Disability, Special Processions, Diminishing Deductibles, Value Rated (Vintage & select symbols)

Inspection Required with Full Coverage	YES: PD Inspection form, photos not required, retain in file; photos required for full coverage on Trikes ONLY

Cycle license	Not required, must have valid U.S. license, (M1 endorsement on drivers license is required for CA Good Driver & Experience Credits)
CA Good Driver	Must have M1 endorsement for 3 years

Paperless	YES - retained signed apps in office
Payment by Phone	YES, Western Union, Credit Card, Dairyland App, Online
Payment Plans	Paid in Full, 3-Pay Plan (premium \$150 +, 40% down), 6-Pay Plan (premium \$300 +, 25% down), 12-pay w/automatic payments for Good Drivers Only at New Business. 12 Pay avilable at renewal for both Good Drivers and Non-Good Driver, call Dairyland to switch plan
Policy Terms	Annual
Proof of Marriage	NO, married includes legally married, deemed married by state law widow, civil union or registered domestic partner
Reinstatement Period	60 Days
Suspended Documents	Verification of Discounts, PD Inspection form, Photos required on Trikes ONLY
Violations	1 violation charge per day (ex. 1 major and 1 minor on same day, we only charge for the major) Within last 36 months, we can quote a driver with 4 or less Minor Moving Violations, 2 or less At-Fault Accidents and 2 or less Major Convictions
